

Casinos - Missouri's Highest Taxed Industry


Missouri casinos operate in one of the highest-taxed casino jurisdictions in the country, paying an effective tax rate of 31% off the top, in addition to other business taxes. That effective rate includes a 21% gaming tax, admission fees paid by casinos for patrons visiting their properties, and other reimbursements to the state.

Missouri casinos contribute more revenue to the state than all of the approximately 60,000 corporations operating in Missouri. Casino taxes rank as the fifth largest source of revenue to the state.

YEAR OF TRANSITIONS FOR

2010 was a year of transitions for the Missouri gaming industry.

Although the recession impacted gaming revenues, the repeal of the loss limit helped level the playing field with other states. The combined result for 2010 was modest growth in gaming revenue and taxes, and Missouri casinos paid \$490 million in gaming taxes to our schools, the state and local communities last year.

Pinnacle's exciting new River City Casino in South St. Louis County opened in March, 2010, generating more than 1,000 permanent new jobs and drawing new casino visitors to the St. Louis area. Overall gaming revenue for the St. Louis region increased by more than six percent in 2010.

In July, President Casino closed, making one of the state's 13

licenses available for a new casino. After a lengthy review process, the Missouri Gaming Commission selected Isle of Capri's proposed \$125 million Cape Girardeau project for priority investigation to receive a casino license.

Finally, the Missouri Gaming Commission appointed Roger Stottlemyre as its new executive director. Stottlemyre was the Missouri Gaming Commission Director of Enforcement

for the past four years and is a former superintendent of the Missouri State Highway Patrol.

"The Missouri casino industry is maturing in a sustainable way," said Missouri Gaming Association Executive Director Mike Winter. "We're proud to provide 11,000+ jobs, hundreds of millions a year in tax dollars, and great entertainment options close to home, right here in Missouri."

"Hearts & Hands" Charity Golf Classic and raised more than \$50,000 for the charity, which provides free dental services to low-income children.

More than 1,700 team members, family and friends from **Pinnacle** Entertainment's Lumière Place and **River City Casino** raised \$51,487 to fight breast cancer through the Susan G. Komen Race for the Cure. Pinnacle provided an additional \$10,000 corporate match and \$35,000 in sponsorships.

Harrah's Kansas City provided a \$15,900 in-kind donation and \$5,000 cash to support the Leukemia & Lymphoma Society's Man & Woman of the Year event at their property. Other big 2010 charitable events that Harrah's Kansas City hosted include the Big Slick Celebrity Charity Poker Tournament to benefit *Children's* Mercy Hospital and Cars 4 Christmas, which provided 20 cars for families in need.

Terrible's Casino supports many organizations including the Arthritis Foundation, Hannibal Regional Hospital, the Alzheimer's Association, the Bikers for Babies/March of Dimes ride and Camp Callahan.

Isle of Capri Casinos honors the legacy of its founder Bernie Goldstein by supporting such charitable events as the American Cancer Society's **Relay for Life** in St. Louis and Boonville, *Habitat for* Humanity in St. Louis, the Don Boscoe Center in Kansas City and the *Humane Society* in Caruthersville. In addition to funding numerous Kansas City organizations and donating more than 12,000 pounds of food, Ameristar volunteered more than 1,400 hours last year. For example, Ameristar team members scrubbed and polished wheelchairs for 43 clients of The Rehabilitation Institute during the Wheelchair Round-Up.

"This was a big deal, since they find it difficult to clean their own wheelchairs," said Dana Chatlin of The Rehabilitation Institute. "One man was preparing for a job interview with a new haircut and clothes, and the clean wheelchair was the final touch."

Ameristar Kansas City also joined the fight against breast cancer as the presenting sponsor of the Susan G. Komen Race for the Cure. Team members participated in the run and helped distribute T-shirts and water.

The Ameristar Cares committee of Ameristar Casino St. Charles

presented \$236,000 to the V.A. Medical Center's Spinal Cord Injury Service the largest donation the organization ever received and possibly the largest donation to any V.A. spinal cord injury facility nationwide. The money will be used to purchase state-of-the-art rehabilitation equipment and expand rehab services for veterans from the greater St. Louis area and eight neighboring states. The V.A. is Ameristar St. Charles' spinal cord injury partner in the Cares workplace giving campaign. Ameristar raised the funds through team member pledges, a company match and a match from the Craig H. Neilsen Foundation.

"PROJECT 21" PROVIDES SCHOLARSHIPS. **EDUCATES YOUTH**

High school students across Missouri are finding creative new ways to educate their peers about the dangers of underage gambling through essays, posters and video entries in the Missouri Gaming Association's Project 21 Scholarship competition.

Conner White of Jefferson City won a \$1,500 scholarship last year for his four-minute video "In the Click of a Mouse" which tells the story of "Joe," a fictional teenager who lost family, friends and grades through underage gambling. The video was shown in Helias High School psychology classes to educate other students.



When asked if crime had increased, all four mayors reported it had not. In some areas, the crime rate had dropped by as much as 40 percent because of increased casino security presence. Others said the highest number of calls to police from the casino was from people who had locked their keys in their cars.

Mayors said they use gaming revenues for community improvement projects such as new government buildings, police and fire equipment, roads, sewer and water projects, parks and downtown redevelopment.
